RESOLUTION

Approval of Adjustment #2 to the FY 2019-2024 Regional Surface Transportation Program (RSTP) Six-Year Financial Plan

WHEREAS, the Roanoke Valley Transportation Planning Organization (RVTPO) is a Transportation Management Area (TMA/TPO) as a result of Census 2010 population; and,

WHEREAS, the RVTPO Policy Board has the opportunity and responsibility to prioritize Regional Surface Transportation Program (RSTP) funds for essential transportation improvements within the Roanoke Valley TPO Study Area Boundary; and,

WHEREAS, the FY19-24 RSTP Six-Year Financial Plan reflects the RVTPO's commitment to fulfill the "Funding Recommended" for projects which have received allocations through the second year (FY20) of the financial plan or for those projects with allocations beyond FY20 that receive additional funding via SMART SCALE or other federal grant programs; and,

WHEREAS, as described in the RVTPO's RSTP Project Development and Selection Procedures (Approved 09-28-2017), the RVTPO Policy Board will review RSTP funding and progress on a yearly basis and update the RSTP Six-Year Financial Plan as needed to reflect current costs, timing, and a new sixth year of funding; and,

WHEREAS, an adjustment to the timing of funding for the I-81 Southbound Improvements between Exit 141 and 140 is needed in order to accomplish preliminary engineering and right-of-way prior to FY24; and,

NOW, THEREFORE BE IT RESOLVED, that the Policy Board of the Roanoke Valley TPO approves the attached FY 2019-2024 RSTP Six-Year Financial Plan including any changes that were included in the motion and seconded of this resolution and forwards this supporting resolution/endorsement to the Virginia Commonwealth Transportation Board.
