1. WELCOME, CALL TO ORDER, INTRODUCTIONS

The meeting was called to order at 9:06 a.m. by Lee Clark, Chair of the RVCR Advisory Committee.

A motion was made to approve the agenda as amended by Linda Hentschel and seconded by Nancy Hans. The agenda was approved by unanimous vote.

3. UPDATES

- a. White Paper Updates: running a bit behind, something sent to coordinators of group by end of week with basic physical outline of report with template and layout instructions. Priorities pre covid, post covid, greatest needs, data. Rather than a unified voice, unified tone to keep individual voices. Editorial group will establish tone. The tone will act as guardrails. This document will act as a funding guiding document to the city regarding Opiate Abatement money. Main goal remains to build the recovery eco system.
 - i. Concerns raised around individualizing too much. Since the paper is coming from an organization it should have one voice. Possible social media coordination can focus on more voices and keep goals prioritized.
- b. SAMHSA Grant Updates: Staff is hired, and project is moving forward through meeting with Health Department and Bradley Free Clinic to ensure no duplications. Salem Fire/EMS program will act as beta program. Roanoke County MOU has been signed for a peer recovery coordinator. Spread out grant and government money by complementing established programs in the area. Program design beginning.
 - i. Dr. Annie Ickes addiction medicine potential for collaboration and plan for Peer Recovery Coordinator to connect.
- c. Recovery Housing Updates: RVCR director has met with city. Developer approved discussion of recovery housing possibilities. Trying to fill the delta, bridging the gap of what we have with what we need. Opportunities with Virginia Housing and Community Development have been applied for, met with them personally and now waiting to hear back. While we are applying for money, trying to make 'addicts in recovery' a dedicated population under the housing group. It is not right now. People in recovery are protected under ADA and that changes the landscape of rules and requirements. As we move forward, we hope to change policy. Things are moving along, but slowly. City Council really paid attention to needs for recovery housing and affordable housing in last meeting.
- d. Recovery Community Center Updates: Mercy Place, Inc. is a registered non-stock corporation and federal 501c-3 papers will be filed this week. Tag line "Where Healing Comes to Grow". A variety of interested folks are meeting, there is a church interested in leasing their space. Developer who has been working on recovery housing has facilitated meeting with pastors and elders of church to discuss. Cannot disclose name of church. City agrees that we need a recovery

community center. Founding board is 65% people in recovery. Plan is to open 7 centers in 5 years. Funding will affect geographic limitations, but the footprint is the same as The Commission.

- i. Concerns raised about access and inclusion of Roanoke County.

4. ADDITONAL BUSINESS

- a. OD Map Update: Health Department requested funding from The Collective Response to pay for OD Map implementation from now to first quarter of 2023. Statewide implementation and financial backing will be required in January 2023 so this would only be bridge until then. Collective Response was unable to assist but recommended ARPA funds.
 - i. Captain Jeremy Hartman described the connection of EMS data from Image Trend Solutions to OD Maps. As of today, this information is being shared manually via email. This creates a lag time. The statewide implementation in January will make this information available immediately.
 - ii. Clarifications about FAACT (Virginia's Framework for Addiction Analysis and Community Transformation) requested. IT Leadership Lauren Gonzalez asked for meeting to be brokered with The Collective Response.
- b. Agenda for December 2022 Stakeholders Meeting: Bethany Hall closing; wrapping up white paper; moving from Zoom to in person/hybrid in 2023; community updates; Mercy Place, Inc.; updates on Peer Recovery Network and SAMHSA grant; engaging and fostering participation from other groups (5-minute spotlight).
