## Evaluation of Public Participation Efforts on the Public Participation Plan

Documenting and evaluating our efforts to engage the public will help us refine our practices to more efficiently and effectively achieve our public participation objectives.

## Public Participation Plan Ad-hoc Committee

The Public Participation Plan Ad-hoc Committee was central to the public input on Public Participation Plan.

The Ad-hoc Committee Procedures state:
Following the adoption of the Public Participation Plan, the following criteria will determine whether the ad-hoc committee was successful.

- The Policy Board adopted a Public Participation Plan.
- Participants were actively engaged.
- Participants felt their participation was meaningful.
- Participants felt their advice was valued.

Meeting minutes of the ad-hoc committee provide evidence of the active engagement of participants.

Ad-hoc committee members were offered a survey after their last meeting to assess whether they felt their participation was meaningful and their advice valued. Twelve people completed the survey. The survey was anonymous. The results indicate that all respondents felt very engaged or somewhat engaged. Most respondents felt their input was valuable and that staff valued their input. Most respondents were unsure whether the Policy Board and/or TTC valued their input.

## Conclusions

## Ad-hoc committee

Having a clear purpose kept the committee engaged. Using a google doc for comments kept tedious word-smithing out of meetings.

## Surveys

Some comments on the surveys indicate there is room for improvement. Staff are seeking training opportunities and pursuing partnerships to create better surveys. MetroQuest is an intriguing new survey tool that has a good record for high numbers of responses. MetroQuest offers public participation webinars that help with designing and marketing surveys and reaching Title VI populations. Virginia Tech professor, Dr. C.L. Bohannon, has provided some resources.

## Final comment period and public hearing

The libraries are willing partners that reach a diverse cross-section of the population. The library system has a delivery service, but this should be used in conjunction with calling individual libraries to make sure the plans are placed in a visible location and that library staff can answer questions. Gluing an envelope to the back of the plan for completed comment forms and having instructions on the front explaining where to put completed comment forms was helpful. Instructions should include the end date for the comment period and RVARC contact information. Include a date field on the comment form.
