Regional Surface Transportation Program Funds Coming to the Roanoke Valley Area Metropolitan Planning Organization (MPO) Study Area



In 2012, the Roanoke Valley Area Metropolitan Planning
Organization (MPO) was designated by the Federal Highway Administration as a Transportation Management Area (TMA), which moved our current MPO to a different "status" among MPOs in Virginia. Along with this designation comes an allocation of federal Regional Surface Transportation Program (RSTP) funds for projects in the MPO's

Study Area that meet certain criteria/ eligibility. The first year of funding for RSTP will be approximately \$8.2 million (double since it covers Fiscal Years 2013 & 2014 -- thereafter approximately \$4.1 million per fiscal year).

Eligible recipients for RSTP funds in our region include the local governments who have all or a portion of their territory in the Roanoke Valley Area MPO Study Area (the Counties of Bedford, Botetourt, Montgomery and Roanoke, the Cities of Roanoke and Salem, and the Town of Vinton); the Greater Roanoke Transit Company (Valley Metro); the Unified Human Services Transportation Systems, Inc. (RADAR); the Virginia Department of Transportation; the Virginia Department of Rail and Public Transportation, the Roanoke Valley Area Metropolitan Planning Organization (for planning studies only); and the Roanoke Valley-Alleghany Regional Commission (for planning studies only).

To get the selection process started, the Transportation Technical Committee (TTC), a technical advisory group to the Roanoke Valley Area MPO Policy Board, has been requesting candidate projects from eligible recipients to be considered for RSTP funding in the next fiscal year. A document entitled Regional Surface
Transportation Program Development and Selection Procedures will be used to review and recommend projects to the MPO Policy Board. It contains the application, details on what kind of projects are eligible for funding, etc. The TTC will score the candidate projects based on criteria, such as regional benefit, safety, increased mobility options, etc., and communicate those scores to the Policy Board. The Policy Board takes the scores under advisement, but is free to make decisions that deviate from the scores. The final decision rests with the Roanoke Valley Area MPO Policy Board.

All applications must be submitted by one of the above-mentioned agencies/governments to Mark McCaskill, Senior Planner and lead MPO staff at the Roanoke Valley-Alleghany Regional Commission (313 Luck Ave., SW, Roanoke, VA 24016) by COB (5:00 pm) on Friday, April 19, 2013.

It is anticipated that projects will be decided at the May 23, 2013 meeting of the Roanoke Valley Area MPO Policy Board. The MPO's selections are then forwarded to the Commonwealth Transportation Board (CTB) for approval as part of the State's Six-Year Improvement Program (at June CTB meeting).

WHAT IS AN MPO?

The U. S. Congress passed the Federal-Aid Highway Act of 1962, which required the formation of an MPO for any urbanized area with a population greater than 50,000. Urbanized areas with populations greater than 200,000 are classified as a Transportation Management Area (TMA) MPO.* TMA MPOs have additional responsibilities such as producing a Congestion Management Process Plan


and obligating Regional Surface Transportation Planning funds. Federal funding for transportation projects and programs are channeled through this planning process. Congress created MPOs in order to ensure that existing/future expenditures of governmental funds for transportation projects and programs are based on a continuing, cooperative, and comprehensive ("3-C") planning process. Statewide and metropolitan transportation planning processes are governed by federal law (23 U.S.C. §§ 134-135). In essence, MPOs are part of a "check and balance" system between the federal, state and regional (local government) levels of government with regards to federal surface transportation funds.

WHO STAFFS THE MPO?

The Roanoke Valley Area MPO is staffed by the Roanoke Valley-Alleghany Regional Commission, who also serves as fiscal agent.

HOW IS THE MPO GOVERNED?

The MPO is governed by a 17 (voting) member Policy Board composed of representatives from the member governmental subdivisions contained in the Roanoke urbanized area and other transportation-related organizations as required by federal and state statute --the Cities of Roanoke and Salem, the Counties of Bedford, Botetourt, Montgomery and Roanoke, the Town of Vinton, the Greater Roanoke Transit Company (Valley Metro), the Roanoke Regional Airport Commission, the Roanoke Valley-Alleghany Regional Commission, the Virginia Department of Rail and **Public Transportation and** the Virginia Department of Transportation. The Board also includes two non-voting organizations - the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA). The Transportation Technical Committee (TTC) serves as the technical advisory group to the Policy Board.

HOW MANY MPOS ARE IN VIRGINIA?

Currently, there are 12 MPOs fully located within the Commonwealth of Virginia: Blacksburg-Christiansburg-Montgomery MPO, Central Virginia MPO, Danville MPO, Charlottesville-Albemarle MPO, Fredericksburg Area MPO, Hampton Roads Transportation Planning Organization, Harrisonburg-Rockingham MPO, Richmond Area MPO, Roanoke Valley Area MPO, Staunton-Augusta-Waynesboro MPO, Tri-Cities Area MPO (Petersburg), and Winchester- Frederick MPO. Three multi-state MPOs that have portions in Virginia --the Bristol MPO, Kingsport MPO, and Metropolitan Washington Council of Governments.
