OVERVIEW

The Annual Comprehensive Work Program is the basis for achieving the objectives and strategies as outlined in the Roanoke Valley-Alleghany Regional Commission's <u>Strategic Plan</u>. The Commission strives to maximize its limited staff and resources by developing a comprehensive work plan based on current needs and priorities of our region.

This work program is a compilation of projects presented by local elected officials, Commission members, MPO members, regional economic development-related organizations and staff. The Regional Commission and the Roanoke Valley Area Metropolitan Planning Organization (MPO) review and rank projects according to importance to the region. Projects are selected by: balancing importance of the project to the region, funding availability, staff time and other constraints to arrive at the projects, the intent is to obtain the most benefit from the least direct cost to the local governments. Requests not included in this year's work program are added to a list of potential projects for future work programs. These potential projects may be included in next year's work program if the need still exists and funding is available.

The work program is revised annually and may be amended as deemed necessary by the member governments that we serve.

URBAN TRANSPORTATION PROJECTS

Long-Range Transportation Planning

Completion of the Constrained Long-Range Plan 2025 Technical Document. Conduct public outreach concerning planning assumptions, environmental justice analysis and other activities in preparation of the next revision of the Long-Range Transportation Plan. Survey recently adopted comprehensive plans and zoning ordinances concerning their effect on land-use transportation assumptions for the Travel Demand Model.

Transportation Improvement Program

As required by federal planning regulations, the Transportation Improvement Plan (TIP) for the Roanoke Valley area is a three-year program of highway, transit, bicycle, pedestrian, safety and transportation enhancement projects receiving federal funds. The TIP is updated every two years and must be approved by the MPO's policy board and the governor of Virginia. Some major activities that will be undertaken include amending the current TIP as needed, preparation of the of the RVAMPO Self-Certification Statement and activities to assure that the Statement is being followed, and the preparation of an annual listing of projects for which federal funds have been obligated in the previous year. It is anticipated that development and adoption of FY 2004-06 TIP will be completed in FY 2005.

Freight Strategies Implementation

Continue support for regional freight forum as a freight advisory group to the planning process. Continue working with staff of localities to integrate freight-planning concepts such as warehousing and logistics zoning, freight staging areas etc. into comprehensive plan and zoning ordinances revisions. Integrate freight planning concepts into Long-Range Transportation Plan revision.

Bikeway Plan Update

Using the model and analysis from Bicycle Suitability Study Phase I (FY 2003) and Phase II (FY 2004), update the 1997 Bikeway Plan for the Roanoke Valley, which covers the MPO service area. (Rural update is planned for 2006). Update will focus on interconnections between activity centers, greenways and existing bicycle facilities to advance bicycle travel as a viable means of transportation.

Intelligent Transportation System Planning – Regional Architecture

Transportation Planning for the Elderly and Disabled

Staff will lead focus groups to identify issues, patterns and indicators of transportation access, safety, mobility and demand issues among elderly and disabled stakeholders. Staff will work with organizations such as the Council of Community Services, Area Agency on Aging and Blue Ridge Independent Living Center to address the short-term strategies. The medium and long-term strategies will serve as inputs into the Long Range Transportation Planning Process.
